





### AVERAGE TEAM SIZE BY \$ AUM








### AVERAGE TEAM SIZE # OF FUNDS



#### 1 Year Growth %







**Assoc** Base S

Total Compensation Range | 160k - 225k+

Notable Data: Rarely do we see carry offered at this level, but more firms offer co-invest to all employees

Mana Base S

Total Compensation Range | 225k - 275k+

Notable Data: Rarely do we see carry offered at this level, but more firms offer co-invest to all employees

Vice I Base S

Total Compensation Range | 275k - 325k+

Notable Data: VP is where we typically see carry eligibility; starting at 25 bps-50 bps

Direct Base S Total C

Notable Data: Almost always carry eligible, starting at c50 bps

Compensation is highly variable based on the size of the firm and how technically aligned a hire's experience is (ie: fund accountant v. portfolio analytics). Base and Total Compensation are only 2 factors to consider. Compensation should be viewed through the five levers of an offer, not simply through the lens of cash. Career growth and an opportunity to have material impact and are vital factors.

#### Associate | Sr. Associate

Base Salary Range | 120K - 150k

#### Manager | AVP (Including Assistant Controller)

Base Salary Range | 160k - 180k

#### Vice President (Including Controller)

Base Salary Range | 225k - 275k

#### Director | SVP (Including Sr. Controller)

Base Salary Range | 250k - 350k

Total Compensation Range | 375k - 500k+
